## HOW KEIO FUNCTIONS

Keio University, the eternal mutual vote. Their duty is to in springhead of liberal thought for the youth of Japan, though once hated by the warmongers as an educational institution of undesirable intellectuals, has reappeared in the limelight of the new era since the termination of the war. In spite of the tremendous current of divergent ideologies, Keio holds its traditional school motto invincibly and unchangingly—independence and self-respect.

It would be worth writing about the administration of our university on this occasion, for the people are absorbingly interested in educational organizations as one of the shortest ways to bring about a nation of alert, democratically minded people. Besides, unlike the government universities, Keio has its particular type of educational system for the carrying out of its two ideals.

As illustrated in the diagram, Keio is an extensive organization including a university, various schools and a large alumni association. Therefore, when a student graduates and becomes an alumnus, he is given the right to suggest and indirectly assist the school administration through the Board of Councillors. The decisive power on important school affairs, particularly on financial problems is retained by the Board of Coun-

In order to simplify the explanation, we can do no better than quote some parts on the Board of Councillors from the General Provisions of Keio.

There is a Board of Councillors consisting of sixty members. Thirty of these Councillors are elected by the votes of the alumni, from among themselves; and the remaining thirty are elected by the votes of the Councillors thus elected, from the alumni. In case a vacancy occurs in the Councillorship, the candidate who gained the largest number of votes among those who failed to be elected at the preceding election, is eligible for the office. The Board of Councillors deliberate on and determine matters concerning the business and financial welfare of Keio. The regular meeting of the Board of Councillors is called once a month by the Executive Committee. The Executive Committee can call a special Meeting of the Board of Councillors if it is necessary. No member of the teaching or business staff of Keio is eligible for Councillorship, but the following persons can appear at the Meeting of the Board of Councillors to express their opinions: the president of the University, the deans of the University Faculties, the dean of the Preparatory Course, the principal of the Commercial and Technical School, the principal of the Technical School, the principal of the Evening Commercial School, the principal of the Evening Technical Schoo, the principal of the Middle School and the principal of the Primary School for Bovs.

In order to carry out the aims Faculties and the University libof education, Keio has Educational Advisers as well as a Keio Advisory and a University Council.

The Educational Advisers give counsel to the president of Keio at his request, on important matters concerning the institution.

#### **Educational Advisers**

- 1) The ex-president of Keio, remaining either as a member of the faculty or of the staff.
- 2) Those either of the faculty or of the staff who have been in uninterrupted service for over thirty years and are appointed to

the advisership by the president.
The aim of the Keio Advisory Council is to keep all departments of Keio in close touch and to accentuate their ideals and method of education. The Council discusses such matters as are referred to it by the Executive Committee. The members, however, can express their opinions regarding matters which are not proposed by the Executive Committee for consideration and demand he discussion of the Council upon

them. The University Council is called together at least once a term by the president of the University, who acts as Chairman at its meetings. In the president's absence the senior dean acts as his proxy. The following persons become the members of the University Council: the deans of the University Training Faculties and the dean and assistant deans of the Preparatory Midwives Training School course, two professors from each

rarian. In the meeting, the following matters are discussel—

- a) Matters concerning University regulations.
- b) Matters concerning the students to be sent abroad.

These matters are always transferred from the professors' meeting of each University Faculty, where they had been already deliberated upon.

- c) Matters concerning the conferring of degrees.
- d) Matters referred to the Council by the President of Keio.

The University Council can make any proposition regarding the educational matters of the institution, to the Executive Committee through the President of Keio.

It must be added that what you read in this short account is how-Keio-functions, but will-how-Keiofunction. Admittedly, this system is one of the most democratic administration among Japan's uniersities room for improvement. These regulations which have been the administrative foundation of this university are now criticized relentlessly and argued actively. With the constant flowing of democracy into the campus, students are naturally concerned with school administration. So far, there seems to be little likelihood of the students' reflecting their views on major school affairs, in-

The transformation from an old Japan, which for centuries had feudalistic elements and had been tostered by militarism, into a new Japan, will not be such an easy task as to be done in a short period.

However, the first step toward this goal must be taken with the successful carrying out of the general election. The elections to be held shortly with the local administration system as the focal point, will not accomplish their expected objectives unless we fully understand their significance and bring to them our enthusiasm knowledge and energy.

The new Constitution, promulgated on November 3, 1946, is slated to be put into effect on May 3, this year. It goes without say ing, however, that there are still problems deserving further study.

Nevertheless, there is no doubt that the fundamental character of a democratic Japan has been determined by the new Constitution In this respect it has grave significance for the progressive development of democracy.

Although the Constitution is the fundamental law of the state, it needs interpretation. In order to make it successful in the national life, it is imprerative that we deepen our understanding of its provisions and disseminate its meaning throughout the country.

Further, in order to make the Constitution the concrete basis of our daily lives, local administration and autonomous systems must be established.

There is no other way for us to attain this objective but to participate positively and to co-operate in the local election cam-

paign. In this sense, we wish to ask the attention and interest of all intellectual people toward the coming series of elections and request their positive guidance and active support.

We do not put our hopes in these established, corrupt politicians. They must also possess strong determination to fulfil these ideals, as well as nobility of spirit and faith in the possibility of reconstructing.

To be admitted as genuinely democratic state in the family of nations, the new Japan must abandon its former self-satisfied idealism; accordingly, the policies of the parties professing to be able to guide the nation must be clearly understood. Such parties must be representative in the true sense; must meet the present day situation of Japan and at the same time have principles common to all democratic countries.

That is to say, excepting the minor parties professing democratic and cooperative principles and the unique Communist Party, the Japan Social Democratic Party deserves our attention.

The Japan Social Democratic Party, however, does not exist as a consolidated party at present. In order to attain its mission at this historic moment in the democratization of Japan, the party, by its clarified ideals and its vigorous practical power, must prove itself as embodying rising power and high ideals. As for the party of cooperative union, we can no see any merits other than its ideal for the nationalization of commodity distribution for the general public, even if we admit its views concerning peace and culture.

In this connection, as long as the party does not clarify the reason for its inevitable development in Japan, and what kind of ideas it has concerning international politics and economics, we may assume that it lacks a solid and logical foundation.

Under these circumstances, new cratic principles in Japan at the general election are not so power ful, while conservative and reactionary factions still have considerable power.

Always my thought would be controlled by others. Did my action ever result from the inevitability of my internal requisition?



## New Theory On The Climatic Change In Japan

Editors Note: Mr. Nishioka is a graduate of Keio University of the year 1939, specializing in History and Archaeology. He has participated in the excavations of prehistoric relics which were discovered on Keio's Hivoshi Campus. He is known for his numreous scientific articles.

(This theory was reported at the Mita Historical Society, Literature Fac., the Keio Univ. on Dec. 4, 1946, and the Nippon Meteorological Society in the Central Meteorological Observatory on Jan. 17, 1947.)

There are many theories about the climatic change in historic time of the world. For instance, an 11-year periodic change depending on the change of sunspots, a 16-year change noted by A. Wagner, or Bruckner's periodic change of 35 years, and so on are well kknown. The wave of 350 years is the longest one which we know.

But now the fact that a 700year wave definitely exists in Japan has been discovered. In 1935, Prof. Shida of the Kyoto Imperial University, first brought the 700-year wave to light on the annular rings of what we call BENIHI, a kind of cypress about 1050 years old which grows on Mt. Ari-san, Formosa. It was however, not clear whether this wave existed or not in Japan Proper. Last year, I received a report on the annular rings of a Japanese cypress of about 800 years, growth at Nagano prefecture, which was measured by Mr. K. Yamazawa. According to this measurement, I prepared a careful diagram on a section paper and was greatly astonished to find that the 700-year wave did exist in Japan Proper. Although this 700-year wave clearly appeared in the diagram, it was, however, two centuries behind that of Formosa. That is, the top of the wave in Formosa occurs in the 10th century and the 17th century but in Japan it is in the 15th. This difference viz. two centuries between the southern and northern districts will suggest some secrets which probably have relation to the fundamental reasons for both of the 700-year climatic changes. Αt any rate, it is beyond doubt that the 700-year wave of climatic change has occurred not only in Formosa but in Japan. I therefore continued to pursue further research in this climatic phenomenon. discoveries and from botanical and in such northern districts of Japan zoological points of view, all of which are shown on the abovediagram and included in its explanation.

In America, Prof. E. Huntington of Yale University, gave us the famous Pulsation Theory of climatic change in California and western Asia in his book "Pulse of Asia", 1907, and "Civilization and Climate" published in 1915. It is very interesting to make a comparison between his diagram and mine. The decline of his curve in the 7th and 13th centuries bear a close resemblance to my wave, as can be observed. J G. Andersson, moreover, reports in his work \*'Researches into the Prehistory of the Chinese'', Stockinholm, 1943, that he found a great deal of evidence which seems to indicate that the climate of northern China was warmer and more humid in prehistoric and early historic times than it is to-day These facts shown by Professors Huntington and Andersson willalso be of importance in order to understand my theory.

According to U.S.I.S., Washington, Nov. 20, 1946, some of the American meteorologists say that the modern atmospheric temperature of America is becoming warmer than in the past, as a result of their observations during 50 years.

In Japan, such observations also have been done by some Japanese meteorologists: And in March of 1937, in a lecture of mine delivered at the joint meeting of the Anthropological Society of Tokyo and the Japanese Society of Ethnology held at the Tokyo Imperial University, I pointed out that, from the archaeological and botanical point of view, the modern climate of Japan is warmer at least by 4° C than that which obtained during the stone age. And now I have given convincing proofs on the existence of a periodic change of 700 years in Japan, and I have corrected a portion of the curve about the change of sun radiant-heat which was shown us by M. Milakowitch in 1930 by the astronomical calculation on amplitude of the ecliptic and the change of the Earth orbit. A period of two or three thousand years is so short a time for astronomists that he left it out of consideration, but my revision will be important for archaeologists or historians in demonstrates that the coldest period in the alluvia epoch must be in the 5th or 6th century, and thereafter the climatic curve rises step by step, although it repeats the periodic change of 700 years. It is my fervent hope and expectation that, in the near future, many scientists will find out the fundamenta reasons for this phenomenon.

PROOFS

Proper as Aomori, Tokyo, Gifu and Wakayama prefectures. These elephants were also to be found till prehistoric times in northern China.

b) Coral which grew on the Pacific shores of Chiba, Kanagawa, Kochi and Miyazaki prefectures was brought there by the flow of the Black Current, and that growing on the coast of Ishikawa province was carried there by a diversion of the Black Current consequent on the subsidence of the land-bridge between Korea and Japan, which was incidentally a route for elephants to enter Japan from the main Asiatic Continent.

cl) Shell-fish (Sanguinolaria and Anadara granosa) and fishes (Muraenesex cinereus, Tqlosusus anastomella, and Taius tumifrons) living in warmer water than there is at present in Tokyo Bay were taken by the Stone-age people for sustenance and later formed the shell-mounds of Shimogumi, Kanagawa prefecture.

c2) The lower shell-stratum of Yoshii and Orimoto shell-mounds contained many Anadara granosa, but in the upper stratum there are no traces or very few of them. These facts indicate that the climate and the sea-water dropped in temperature from a previous warmer period.

c3) Teeth of fur-seal were found from Moroiso shell-mounds, Kanagawa prefecture.

d) Shell-fishes Natica janthostoma and Mactra sachalinensis living in cold currents were discovered from shell-mounds such as Takekuneda and Miyadaira, Ibaragi prefecture.

e) The temperature of the climate and sea-water changed again to warm, and Anadara granosa are found in the Fumigaoka shellmound, Kanagawa prefecture.

f) Natica janthostoma and Mactra sachalinensis were taken again from the Kasori shellmound, Chiba prefecture, which from the archaeological point of view, chronologically belonged to a later type of shell-mound in Japan.

g) Some special kinds of human clay-doll which seemed to be wearing snow-goggles like Eski-mos or Siberians to protect their eyes from glare were found from ancient sites in the northern provinces of Japan.

h) Horse-chestnuts were excavated from ancient sites at Karako, Nara prefecture, and at Shimpukuji, Saitama prefecture. There are none of this plants existing in those places at present. We can see these plants in cooler places, such as in deep mountains or in the northern provinces.

#### Students Earn While They Learn

Under a plan known as the Cooperative Employment Program" many high school students in the United States earn while they learn, spending their mornings in school and afternoons at work.

Their combination of school training and practical experience is made possible through the cooperation of merchants, manufacturers, banks, business offices, and printing establishments.

A student receives theory and job training in school for his chosen work and simultaneously the opportunity to perfect himself in on-the-job practice. In addition to the pay he receives for his work, he obtains scholastic credits toward a senior High School diploma. Furthermore, when he wins his High School diploma, he is assured of a full-time job at his place of employment.

The cooperative employment program is gaining favor in larger cities of the United States. In Washington, D.C., the plan is operating in six High Schools, with 140 students participating. High School teachers in charge of the program make monthly visits to the cooperating business concerns to check up on the students' work. Rating sheets on a student's progress on the job are made a permanent part of his school record.

The plan is proving successful because the part-time jobs and school courses are interrelated. A student who works in a dry goods store or a clothing store receives basic training in school to learn the qualities of textiles and fabrics. A commercial student receives sound business training in office routine and develops faster speed in stenography and typing. Boys become proficient faster in machine shops, and printer's apprentices receive a broader knowledge of the craft through the schooling they receive.

The cooperative training saves time for employers and business men since they do not have to devote as much unproductive time to training new workers. student earns his way and becomes better fitted to fulfill the requisites of his chosen field of work.

Financial Director Kanzaki, who has taken a very active interest in the rehabilitation of the university since he assumed the office, lamented the desolation of the Enzetsukan which once was pride of the institution, and determined to repair it at once. The repair cost is estimated at about \(\frac{1}{2}\)500,000 and the present plan calls for its completion by the middle of May in time for the celebration of the Ninetieth Anniversary of the founding of Keio-gijuku.

cluding the election of the president. Some of the students claim the right to participate in important school administrative matters with the Board of Councillors. This action must not be regarded as a mere demonstration of a handful of progressives, but as a noticeable movement demanding the establishment of three-board system. On the other hand, the rest, feeling the difficulty of technical handling in such matters as school administration by the students, demand wider range of administrative right for deans of faculties.

Moreover, according to a SCAP directive, most of the members of the Board of Councillors who have had the most decisive power in the major problems have resigned. Therefore, it is no exaggeration to say that Keio is now confronted with an administrative crisis. In view of past experience, nothing is so important for the students who stand by the University and are proud of Keio, as to think seriously about the functions of the university.
